NOTIFICATION

This is in continuation to the Notification reference No. DSE/SPCD/ADM(1.1-A)/2021/1150 Dated 10th June, 2021 and the email sent by Chief SPCD, DSE, MoE on June 27th, 2021, the following will be implemented by BCSEA from the academic year 2021:

Year-end Competency Based Assessment Tests for classes VI and VIII (CBAT-VI and CBAT-VIII)

The year-end competency based assessment test questions with their model answers and marking rubrics of the classes mentioned above shall be prepared by BCSEA. As endorsed by DSE, MoE, these will be sent to schools in the form of encrypted soft copies. In order to safeguard the confidentiality of the question papers, the passwords will be shared with the schools only in the mornings of each scheduled test paper. The schools shall then print out the question papers during the morning hours and administer them in the afternoon of the same day as per guidelines provided by BCSEA. The schools shall evaluate the papers and declare the results.

Regular support and monitoring will be provided by the curriculum and BCSEA professionals.

The subject-wise question paper pattern, total marks and timing will be as per the sample sent by REC.

- 4. There will be a written examination in Agriculture for Food Security.
- 5. All performance tasks under Continuous Assessment Weighting as given in the Assessment Matrix shall be school-based and assessed by respective subject teachers on a continuous basis as per the Assessment Matrix. The school assessment committee shall be responsible to audit and maintain assessment records on a regular basis to track progress of the student learning in different subjects and to ensure that assessment is carried out as intended. The subject teachers shall submit the CA marks to the BCSEA focal (Administrative Assistant) for entry into the BCSEA school dashboard as per the directives from the BCSEA.
